Q: In your opinion, what can we expect this year from the self-entry MEIRA Annual Report Award compared to the previous editions?

I think this years 'self-entry' approach is a great evolution for the Awards. Previously all available reports within the region were reviewed, but given the

numbers only a quick review was possible. This year we have adopted a panel of judges and have expanded the review criteria, this approach enables us to focus on the best reports in the region. Year on year we've seen an improvement in the quality of the reports and those at the top end of the scale are comparable to reports produced in the international markets. I would encourage all IR teams to submit their reports for review even if it's not a winner this year it will provide a benchmark to improve on in subsequent years.
