

Q: From your perspective, what is the investment community expecting from the regional listed companies for the upcoming year regarding their communication and disclosure practices?

The disclosure practices for listed companies are clearly tabulated and subject to extensive regulation. However, as the collapse of Al-Abraaj demonstrated, corporate malfeasance can still flourish in a corporate culture in which secrecy and nepotism are rife. To counteract this, truly independent board directors are critical to ensure that frank disclosure and communication practices are upheld. Gender diversity at board and management level is also important: several studies have found higher female

representation at board level corresponds with less corporate governance malfeasance.
