Investor Relations Officers to become mandatory for listed companies in Qatar



Qatar Stock Exchange announced this week that the IR Rules, which will be mandatory for companies listed on the QSE, will be valid for all listed companies as of October 1st, 2019. Each company listed on the main market of QSE will be required to appoint an Investor Relations Officer, create and maintain a

dedicated IR section on its website, and hold at least one investor call conference, as well as submitting an annual report to QSE on the company's compliance with the IR rules and requirements.


#### **About Middle East Investor Relations Association**
