Like anywhere, particularly as IR develops locally, if not regionally, MEIRA seeks to find the best solutions for you as IROs. We are often asked what works best and you are in as good a position to tell us given your own experience, so again, do let us know what you think as we plan ahead for 2020 and beyond. Rest assured, we are working hard to make all MEIRA training more accessible and ideally, cost-effective, for the growing community of new IROs in the region. Onwards and upwards, all of you!

It is encouraging to read of AIRA's (our Australasian counterpart) recent annual IR survey that reflects the growing influence of IR has led to an increase in remuneration in that part of the world - the median fixed pay is up year-on-year. This would make sense if IR is generally seeing an increase in tasks expected of the role, including ESG management, for example. Some of this growth is on the back of market structural changes that have adversely affected the provision of services from both buy- and sell-side which, in turn, has put a bigger onus on IR to fill any gaps in managing the investment community. This is good for IR as it takes on more direct engagement with investors. That's where you can make a difference, IROs! And guess what the most essential attribute of effective IR is, according to the survey? Well, not unexpectedly, it's based on your trustworthiness and integrity as a bona fide spokesperson for your company - ultimately driven by strong relationships with both internal and external stakeholders. Much to do and live up to!
