In many ways, as we know, statutory reporting requirements form the basis of IR. Accordingly, we thought that after a year like 2020, it makes most sense to go back to the basics, the bedrock of your IR, the annual report. Clearly, after a year like 2020, other factors, including ESG, should feature more, not least the people or social aspect. You are already doing lots of good things, so this should all be featured in your annual reports. In our awards' criteria, we highlight the importance of extra- or non-financial reporting and it is up to you to decide what is in and what isn't. Of course, it depends on your business model and what is relevant, if not material, to the business and the way you manage it and present it. Look internally and then ideally, given it is useful to running the business, use it externally as part of your IR.

We conclude later today with our latest discussion of developing an ESG roadmap, step by step, so join us - see registration link. We will hear from Dr. Christine Chow, an international ESG expert, who can help us to put into perspective what investors expect. At the very least, we will be in a position to start, if not build on what you are already They understand the significance of ESG and how this can be used as an opportunity and presented accordingly in our regional context.


