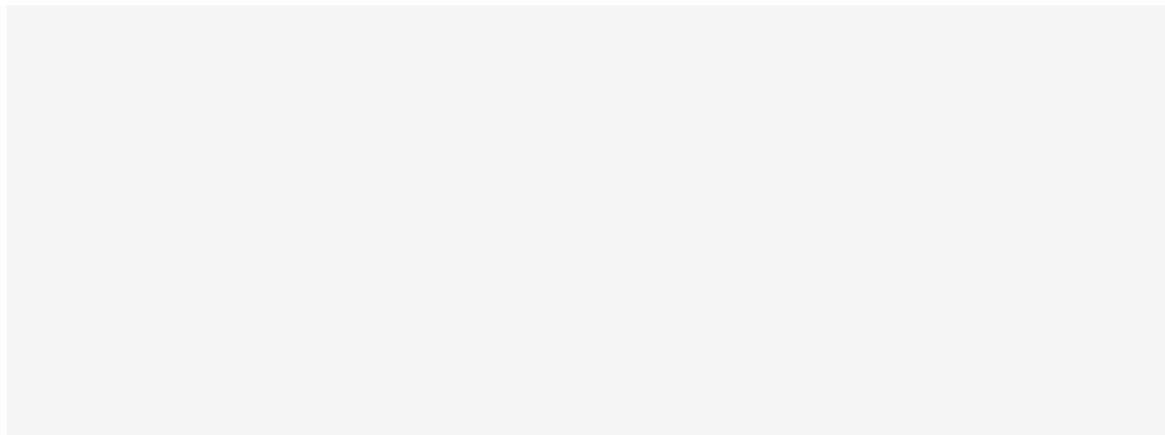
The "2021 IR Practitioners Survey" will **close today**.
