#### GCC Earnings Calls Sentiment Reaches New Peak In 4Q 2021

Iridium Advisors, the leading IR consultancy in the Middle East, analyzed over 5 million words from more than 1,000 Earnings Calls using its proprietary Quant Lens NLP algorithms to investigate how GCC sentiment trends have evolved for the 4Q 2021 earnings cycle. Its new report reveals that GCC Earnings Call sentiment is at its highest level since 2019, further improving for the seventh consecutive quarter from its all-time low in 1Q 2020, when the Covid pandemic was at its most disruptive.

The improvement in sentiment coincides with a further reduction in the number of mentions of Covid and other health-related words in earnings
