

# Steady GCC Sentiment in Turbulent Times

Al-powered analysis of 1Q 2024 Earnings Calls

Iridium Advisors' AI analysis of 1Q 2024 earnings calls reveals sustained market resilience amid challenging global and regional conditions. The Iridium GCC Earnings Call Sentiment Index shows a slight dip of 3% from the previous quarter, yet remains near the record highs of 2019, underscoring the enduring strength of the GCC markets.

Despite a marked decline in analyst sentiment during Q&A sessions, potentially reflecting caution about future sustainability, 61% of GCC companies exceeded analyst expectations. This quarter also noted a strong correlation with the MSCI GCC Index, highlighting how closely the sentiment index reflects broader market movements.
