


UAE has overtaken Saudi Arabia across all major Global Emerging Market fund positioning metrics

Our analysis covers actively managed GEM funds with over \$435 billion in assets. Key takeaways:

- GEM fund positioning: 62.6% of GEM funds have allocated to the UAE, with an average fund weight of 1.40% and 40.6% of overweight positions.
- Sector preference: 48.5% UAE real estate, 45.6% KSA Financials, 37.1% UAE financials
- Peak ownership: 36% Emaar Properties, 24% Al Rajhi Bank, 23% Aldar Properties


